Once enrolled, fees will still be fully payable for all students in aftercare irrespective if they attend in the holidays.

Payments: The school fee payments may be made termly and monthly in advance on or before the 1st of the month.

Sibling discount: The eldest child in the family pays the listed tuition fees. Sibling discounts will be applied as per the fee structure.

Outstanding Fees: If fees are in arrears, the school reserves the right to take the necessary steps as per the conditions of the contract.

Notice Period: A Calendar month's notice is required for students who joined the school within 1 – 3 months of attendance and a full term's written notice is required for students attending longer than 3 months if you intend to remove your child from the school. This notice must be written and handed in during the last week of the month before the notice month or of the term before the notice term.

The Account Holder undertakes to give the school thirty (30) calendar days written notice of termination of the enrolment of all primary school additional services, i.e. aftercare, transport, etc. failing which, the account holders and the surety and co-principal debtor shall be liable for the full amount of the tuition fees for the following month
